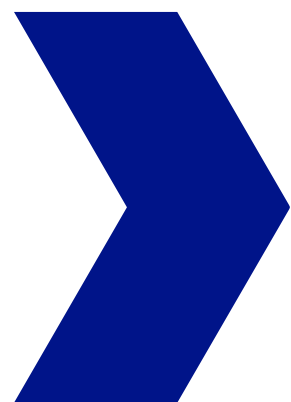

# SIAN - CERTIFICATE OF CONFORMITY TO THE CISS ITS

DATAGROUP has received a certificate from the State Service for Special Communications and Information Protection of Ukraine and guarantees its customers a high level of Internet access node protection. The operator's comprehensive information security system is confirmed by the Certificate of Conformity of the CISS ITS of the secure Internet access node, which meets the requirements of the regulatory documents governing technical information security in Ukraine. In accordance with the National Security and Defence Council's requirements, state-owned bodies, enterprises, institutions, and organisations are prohibited from entering into contracts and purchasing Internet access services from electronic communication service providers that do not have documents confirming that their information security system meets the established information security requirements.



# ISO/IEC 27001 CERTIFICATE

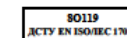

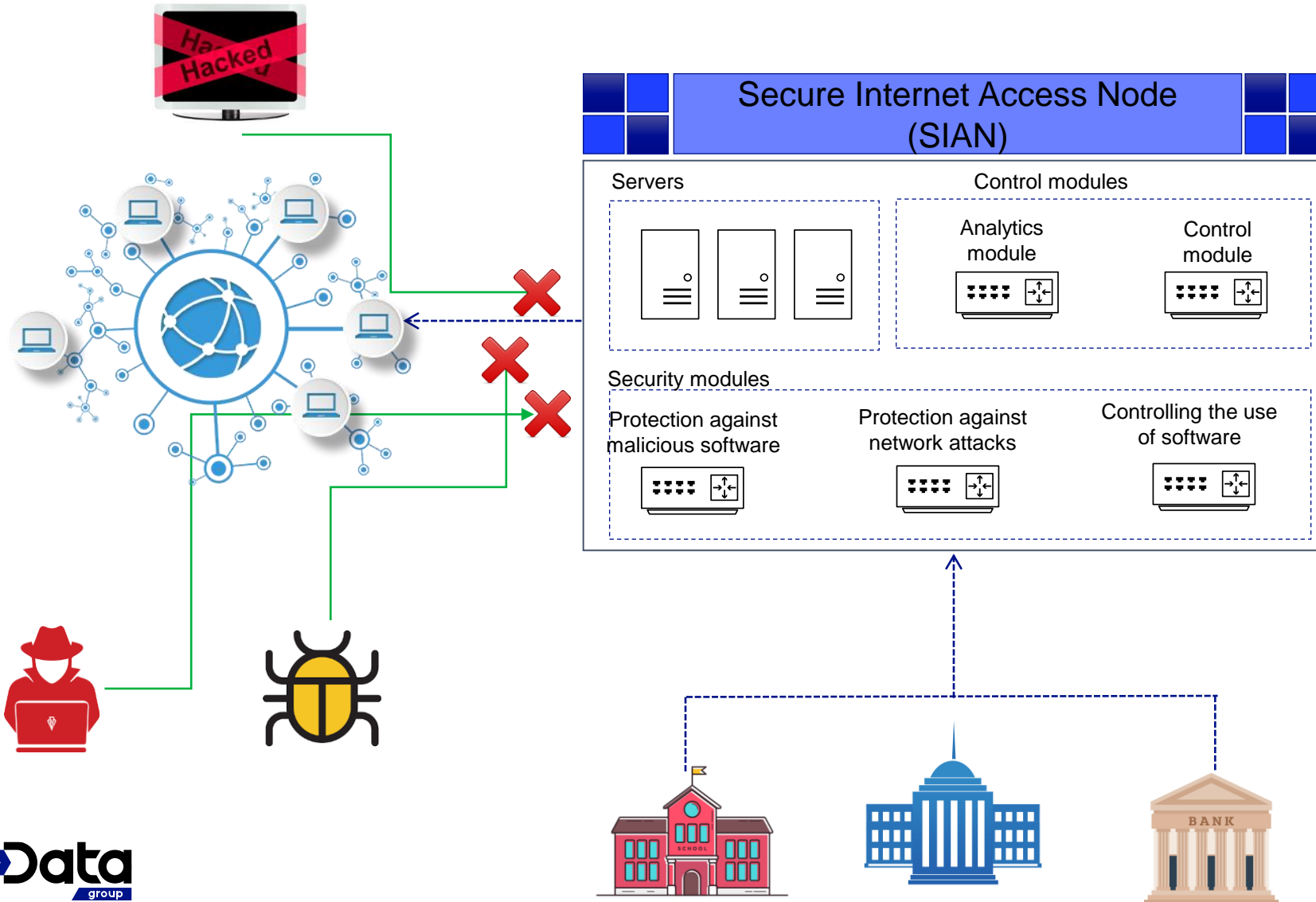

## SIAN - Target audience

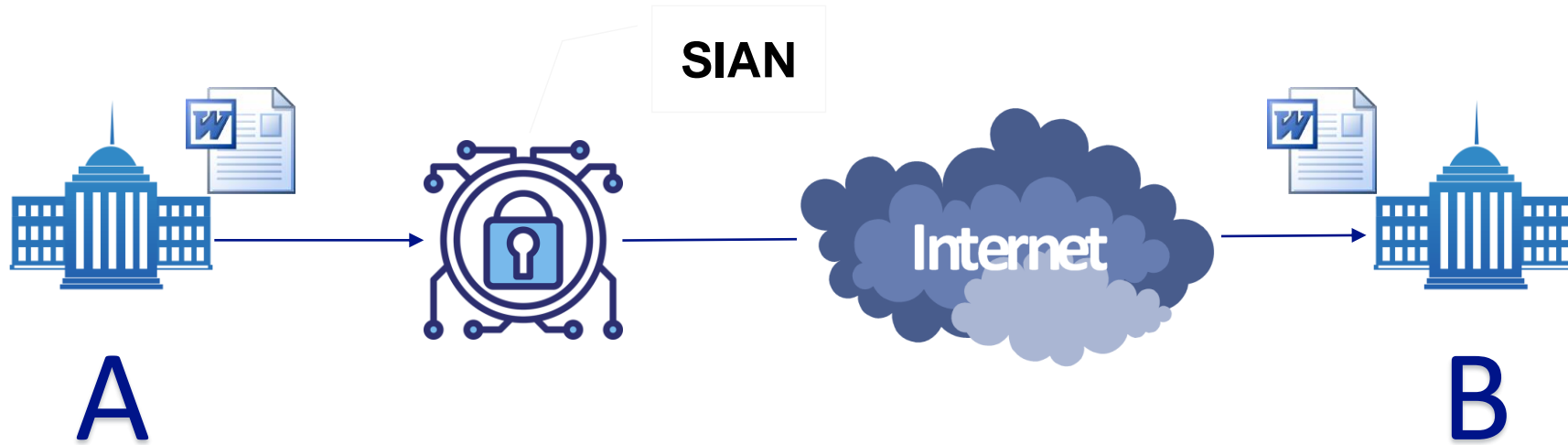
1. Consumers defined in the "Procedure for the provision of confidential communication services to public and local authorities, state-owned enterprises, institutions, and organisations" approved by Resolution of the Cabinet of Ministers of Ukraine No. 1519 dated 11 October 2002, and which are **budgetary institutions** in accordance with paragraph 12 of part one of Article 2 of the Budget Code of Ukraine
2. **State authorities** shall access the Internet through the system of secure access of state authorities to the Internet of the State Centre for Cyber Defence through providers of electronic communication networks and/or services that have secure access nodes to global data networks with integrated information security systems with confirmed compliance, or through their own secure access systems to the Internet with integrated information security systems with confirmed compliance. This requirement does not apply to information and communication systems of foreign diplomatic missions of Ukraine.
3. **The critical information infrastructure facilities** shall be connected to the Internet, through those providers of electronic communication networks that have secure access nodes to Internet with established comprehensive information security systems (ISS) with confirmed compliance.
4. **Other legal entities** and private entrepreneurs.
